

Terms & Conditions

Tournament Notice

By booking this reservation, you confirm that you are affiliated with the selected team, registered in the tournament. This reservation will be credited towards the room nights required for the team to participate in the event. Please note that cancelling this reservation at any time may cause the team to fall below the minimum required room nights and may affect the team's tournament acceptance status or result in a financial penalty.

Minimum Room Night Requirement

This event requires each team to maintain and utilize a minimum of 15 room nights in order to remain eligible for participation. Failure to do so will immediately affect the team's acceptance status and may result in a financial penalty in order for the team to participate in the event, at the sole discretion of the Tournament Director.

Room Block Deadline

All rooms must be reserved by 12:00 noon (ET) on 12/03/2024. Any contracted rooms, not guaranteed by a valid credit card, will be automatically released at this time. You may only hold up to three rooms under one name. THS reserves the right to reduce your block or adjust your Room Block Deadline, if you fail to reserve at least 50% of the contracted rooms within 30 days of booking. In the event such block revision is necessary, you will be contacted by THS prior to adjustment.

No charges will be placed on your card at the time of making this reservation, however a card is required to secure a team reservation. If the credit card submitted is refused for payment for any reason, you agree to provide payment within 24 hours of notice or the room(s) will be cancelled.

Deposit Refund Policy

Refundable if cancelled prior to the Cancellation Deadline (please see below), as long as the team you are traveling with is maintaining their

contracted minimum room night requirement.

You may reduce or cancel the entire block prior to 12 noon ET, 12/30/2024 without penalty. Cancelling more than 20% of the total contracted room nights after 12 noon ET, 12/30/2024 will result in a charge of one night's room and tax, multiplied by the minimum length of stay, for each room cancelled. Individual reservations within this team block can be cancelled without penalty prior to 12 noon ET, 01/27/2025, as long as it does not exceed 20% of the total contracted room nights. Modifications, such as shortened stays received after 12 noon ET, 01/27/2025 will be assessed a one night's room and tax penalty,

**Unavailability of Guest
Rooms**

The parties agree that on occasion due to unanticipated circumstances, the hotel rooms reserved may not be available. The Hotel and THS will use reasonable efforts to avoid such situation impacting the group. If upon receipt of your rooming list information the Hotel notifies THS that your reservation cannot be accommodated, you will be provided the following: Accommodations at a comparable hotel as close as possible and at no charge to the guest for the first night; Compensation for loss of free breakfast and/or free parking, if applicable; Priority reservations for the first available room at the Hotel the following night; If a room becomes available at the Hotel for the displaced guest and the guest elects not to return to the Hotel, the Hotel and THS will have no further obligations under this clause.

***In the event that the hotel is unavailable due to circumstances beyond their control, such as acts of God, war, government regulations, national health crisis (including but not limited to the COVID-19 pandemic), disaster, strikes, or civil disorder to the extent that such circumstance makes it illegal or impossible to provide or use the Hotel facilities, THS will assist you in the relocation of your reservation. The individual accepting these terms and conditions recognizes that the circumstances described herein are beyond the control of the hotel and THS, and therefore understands that the compensation outlined above will not be provided.**

Hotel Amenities, Charges & Fees

Parking, Internet, resort fees, taxes and other surcharges are set forth by the hotel and are subject to change without notice and are not contractually guaranteed by the hotel, the event or THS. All guests will be required to provide a valid method of payment to cover incidental charges at check in. For your safety, some services and amenities may be modified during your stay. For details about food and beverage service and the use of public amenities such as fitness centers and swimming pools please check with the hotel for the latest requirements and service offerings.

Special Requests

Please note that requests for items such as rollaway beds, refrigerators, microwaves, adjoining rooms, etc. can be made at the time of booking. The hotel will attempt to honor all requests, however, they cannot be guaranteed. Please contact the hotel to inquire about the availability and fees associated with these items.

Swimming Pools

Confirmation Numbers

No-Show Notice

If you do not check into the hotel on your scheduled arrival date, the credit card used to guarantee the reservation will be charged a no-show penalty fee of one night's room and tax, multiplied by the minimum length of stay and your reservation will be cancelled. To avoid this penalty fee, please contact the hotel if your plans change on the day of arrival, or if you need to arrive after midnight (local hotel time). Please note: if you no-show and your reservation gets cancelled, the hotel may be sold out the next day and may be unable to reinstate your room.

Damages to Hotel Property

The individual accepting these terms and conditions hereby agrees to adhere to the rules and regulations set forth by the hotel and will consent to signing a conduct policy if requested by the property. Additionally, you agree to promptly notify the hotel of any damage incurred to the property during your stay and acknowledge liability for damages caused by you or your accompanying guests. The hotel reserves the right to assess and charge for damages, payable either upon check-out or through invoicing post-event. Non-compliance with these terms may result in removal from the property or legal action.

Governing Law & Jurisdiction

This Agreement in its interpretation and application and enforcement shall be governed by the law of the State of New Jersey without application of its conflict of law provisions, and any legal action commenced by either party seeking interpretation, application and/or enforcement of this Agreement shall be brought only in the State of New Jersey.

Non-Transferable

Any rights or obligations under this agreement cannot be transferred to another group or individual. Contracted rooms cannot be resold or

otherwise transferred and must be used by the designated team and individuals associated with it.

Hold Harmless

The individual accepting these terms and conditions recognizes that THS has no control over individual hotel conditions and, as such, holds THS harmless from any illness or injury arising from or relating to their stay.

Authorization

By accepting these terms and conditions, the individual acknowledges and agrees to be bound by the terms and conditions set forth herein. The individual further acknowledges and agrees that they are solely responsible for adhering to all terms and conditions outlined, including but not limited to payment obligations related to their hotel bill and credit card charges. In the event of any dispute arising regarding payment of the hotel bill or credit card charges, the individual agrees to abide by the terms set forth in this agreement and acknowledges their responsibility for any charges incurred.
